

CINCINNATI DINNER TRAIN CAB RIDE RULES AND REGULATIONS

- No more than one rider in the cab at any one time.
- Must be at least 18 years of age
- Cab rider must be able to stand, walk at least 100 yards without hesitation, sit, climb ladder/stairs without delay and without assistance and without the aid of any assistive device.
- Use of a camera for photography is permitted. Video recording is not permitted.
- Mobile phones must be OFF or in 'airplane mode'.
- No self-contained breathing equipment (oxygen) or service animals.
- All riders must wear proper clothing (shorts, skirts and tank tops are not permitted). Full length slacks are required.
- No open-toed shoes (sandals, flip flops, etc.) or high heels.
- Cab rides may not be available on some departures.
- Firearms and/or weapons of any kind are strictly prohibited from the Cab.
- Riders must not be under the influence of alcohol, illegal drugs of any kind, or prescription medications that would cause drowsiness or impaired judgement. This includes the understanding that no alcohol or illegal drugs may be consumed on the day of participation.

Your safety and the safety of all passengers and crew aboard the train is our number one priority.

Our engineer's primary responsibility is to operate the train safely and efficiently. While engineers are free to converse with you at their discretion, there are important duties they must attend to, without becoming distracted. Riders must carefully and completely follow all instructions from the engineer.

Climbing into the cab requires strength, balance and agility using both arms and both legs. Stairs are open metal grates. Steel decking surfaces may be slippery or uneven. The sensation of motion within the locomotive cab is different than aboard a passenger rail car. Riders may find space in the locomotive compact and confining. Diesel fuel and exhaust fumes, horns, bells and mechanical noises are part of the sensory experience riders must be prepared for. We reserve the right to refuse admittance if a person appears to be under the influence of drugs and/or alcohol.

RELEASE, WAIVER, HOLD HARMLESS AND INDEMNIFICATION

The undersigned, in consideration of the opportunity to ride in equipment owned and operated by the Cincinnati Railway Company, does hereby knowingly, freely and voluntarily waive any right or cause of action of whatsoever kind or nature against the Cincinnati Railway Company, Cincinnati Dinner Train, Genesee & Wyoming Railroad, Indiana & Ohio Railroad, agents or employees arising out of any claim whatsoever, which results from any injury to body, life, limb, or property of the under-signed resulting from the riding, use of, or presence on and at railroad equipment and facilities by the undersigned.

Further, the undersigned shall save and hold harmless, and indemnify the Cincinnati Railway Company, Cincinnati Dinner Train, Genesee & Wyoming Railroad, Indiana & Ohio Railroad, their owners, officers, agents or employees, from and against all judgements, orders, decrees, attorneys fees, costs, expenses, and liabilities, the undersigned may suffer arising from or out of any such claim, investigation or defense thereof which may be entered, incurred, or assessed against the undersigned, as a result of the forgoing. Firearms and/or weapons of any kind are strictly prohibited from all Cincinnati Railroad and Cincinnati Dinner Train railroad equipment and property.

We reserve the right to cancel the Cab Rider's participation if deemed necessary due to any potentially unsafe conditions or situations at which time the cost of the cab ride will be refunded.
